NOTE: ATHLETES COMPETING IN TWO CATEGORIES ON SEPARATE DAYS NEED ONLY TO WEIGH IN ONE TIME PRIOR TO THEIR FIRST DAY OF COMPETITION.

ELIGIBILITY FOR JUNIOR ATHLETES

Contestants may participate if they meet the following eligibility requirements:

- 1) A United States citizen (copy of passport or birth certificate required).
- 2) A current member in good standing of USA JUDO (United States Judo, Inc.) A copy of membership card is required or circle on bottom of entry form either "Will bring current membership card to event" or "Will purchase membership at event."
- 3) Born between 1990 and 2003 inclusively for all non-collegiate categories.
- 4) a. Holder of a recognized rank (USJI, USJF or USJA) of Shodan (1st degree black belt) or higher (copy of rank certificate, current USJI membership card having the rank verification symbol "(V)" printed following the rank, or rank card issued by the USJF or USJA National Offices, required),

OR

If rank is lower than Shodan, the Certificate Regarding Non-Black Belt contestants must be completed and signed by a coach who holds a recognized black belt rank (proof of coach's rank required).

ELIGIBILITY FOR COLLEGIATE ATHLETES SENIOR & NOVICE DIVISIONS

Student may participate if he/she meets the following eligibility requirements. USA Judo will no longer monitor and require submission of transcripts for this event, however, continues to emphasize education as a priority for competing.

- 1) A current member in good standing of United States Judo, Inc. (USA Judo). A copy of your membership card is required **OR** you may purchase membership at the event.
- 2) Is at least fifteen (15) years of age as of the date of the tournament and under the age of 28 as of December 31 of the year of the tournament. **Proof of age consisting of birth certificate, passport. Note: A driver's license is not acceptable as proof of age.**
- 3) Is currently enrolled as a full-time student in an undergraduate program as defined by their institution. The student must carry no less than 12 semester hours or 12-quarter hours, nor have received or satisfied the requirements for a baccalaureate degree.
 - a. *A student with eligibility in his final semester graduating at the end of the term with less than 12 units is eligible for the championship.*
 - b. *A student who is enrolled in a graduate program at the institution from which he/she received an undergraduate degree is allowed to participate in the Championship, so long as he/she has eligibility remaining, and he/she participates within the applicable five-year or ten semester period.*

COLLEGIATE NOVICE DIVISIONS: Those below the rank of sankyu (brown belt) are eligible. Please fill out the NOVICE ENTRY FORM AND SUBMIT APPROPRIATE PAPERWORK. Collegiate Novice competitors should ONLY FILL OUT THE NOVICE COLLEGIATE ENTRY FORM.

SPECTATOR ADMISSION FEE

\$12.00 per person per day. Children under 8 years of age are free. Children 9 -12 years of age are \$8 per day or two days for \$14. Two-day adult passes are \$20.00.

- Olympians will be granted free admission and floor passes to the event.
- USA JUDO Life Members will receive free admission (spectator seating only).

CHAMPIONSHIPS HEADQUARTERS

This year USA Judo will offer the option of four hotels. There will be a shuttle service that runs from 9:00 a.m. – 9:30 p.m. on registration day from all USA Judo hotels to the headquarter hotel so that members may be able to attend registration and meetings held in the evening prior to competition. York Expo Center's Toyota Arena is approximately 10-15 minutes from all the USA Judo designated hotels. Free designated buses will transport competitors and coaches between the hotel and the venue. The buses will operate throughout the competition. Parking for spectators will be available free of charge for those renting cars.

RULES FOR JUNIOR (NON-COLLEGIATE) CATEGORIES & METHOD OF COMPETITION

The Championships will be conducted in accordance with the Contest Rules, Organization Code and Sporting Code of the International Judo Federation, as revised for the USA JUDO Youth and Scholastic National Judo Championships. These rules include, but are not limited to draw, weigh-in, length of contests, and competition procedures. **Competitors fighting in more than one category need only**

need only weigh in prior to the first day of their competition. Junior points will no longer be awarded on the junior roster for medals won in Collegiate divisions. **Athletes competing in Junior divisions do not have to be enrolled in academic institutions to be eligible to compete; however, they must be enrolled if they are seeking to be named Academic All Americans or High School All Americans. An academic verification form is enclosed at the end of this package for those competitors**

Method of competition for junior categories will be standard (“true”) Double Elimination System with winner’s and loser’s brackets. The winner of the loser’s bracket will compete against the winner of the winner’s bracket for 1st and 2nd place. The first one of these two contestants to have two (2) losses will be placed second; the other will be placed first. The loser of the loser’s bracket will be placed 3rd. For categories of under five contestants, round robin will be the method of competition.

There will be no seeding for any junior categories with the exception of the IJF Junior and Juvenile B divisions where the top four athletes will be seeded in each division. In the event a seeded athlete is not present, the other athletes WILL move up in seeding.

Juniors winning medals in the IJF Juniors, Juvenile A, Juvenile B, Intermediate 1 and Intermediate 2 will be awarded 10 points for a gold medal, 6 points for a silver medal and 4 points for a bronze medal on the Junior Elite National Roster that corresponds to his or her weight division.

The draw will be conducted using USA JUDO approved software. The draw will be random, with the restriction that players having the same State affiliation will be placed as far apart in the bracket as possible.

The Texas Match Scheduling system will be used. Contestants will receive a card specifying their contest area number and match number. All contestants are expected to report to their assigned contest area three matches prior to their assigned match number.

- **Determination of Weight Category:** Athletes are asked to make a preliminary declaration of weight on the entry form or at check-in/registration. However, in this tournament the athlete’s actual weight at weigh-in will determine the category of competition, i.e. the athlete does not have to “make” the declared weight.
- **Shime-waza rule:** Shime-waza (choking) allowed in Juvenile A, B and IJF-Junior divisions only.
- **Kansetsu-waza rule:** Kansetsu-waza (arm locks) allowed in IJF-Junior and Juvenile B divisions only.
- **Injury Rule:** Decisions as to whether an athlete may continue if injured while on the mat, are to be resolved in accordance with IJF rules; such decisions occurring off the mat or not covered by the IJF rules, are to be made by the coach, the athlete, and the Team Doctor. If there is not a unanimous opinion among these three individuals, the athlete **may not** continue (Board-approved October 22, 1998.)
- **Match lengths:** Bantam, Intermediate, Juvenile A - 3 minutes
Juvenile B and IJF-Junior - 5 minutes
- **Judo gi color:** Although optional, USA JUDO encourages the wearing of a blue judo gi by the “blue” side competitor. The “white” side competitor must wear a white judo gi. Competitors are responsible for appearing in the correct color gi

COMPETITORS AND THEIR COACHES ARE RESPONSIBLE FOR PROVIDING THEIR OWN BLUE AND WHITE BELTS FOR THIS COMPETITION

If a contestant has no one else in the division he or she weighed in for, the player may one weight category where there are matches (see Consent for Weight Change Form). Any changes must be made prior to the start of the draw!!! If a contestant moves up a weight instead of accepting an uncontested gold medal, that athlete cannot receive points for the uncontested division. Therefore, he/she can CHOOSE to remain uncontested and receive points on the appropriate Junior Elite National Roster OR to move up and have fights and a chance to earn points in the next division. In NO CASE can an athlete move up in age except to the IJF Jr division.

- Divisions will be posted for coach/player inspection as soon as possible after the close of weigh-ins on each day. One hour later, any necessary corrections will be made, the draw will be performed, and brackets, with match numbers, will be posted.
- Refer to the Eligibility Rules for Pre-Qualification Requirements.
- Athletes placing in these Championships in the Intermediate, Juvenile and IJF-Junior categories will be considered Junior Elite Players.
- Only contestants who are citizens of the United States and eligible to represent the United States in international competition may participate in these Championships.
- Authorized coaches will be given admission onto the venue floor. One coach per contestant.

RULES FOR COLLEGIATE COMPETITORS & METHOD OF COMPETITION

Modified Double Elimination System with winner and loser's brackets will be used. Play will progress in the winner's bracket in a single elimination format until one match remains (the "final" match.) The winner of the final match will be placed first. The loser of that match will be placed second. All players who lose prior to the final match will be placed in the loser's bracket. The winner of the loser's bracket will be placed third. Juniors will no longer be awarded points on the junior roster for winning medals in collegiate categories. **Competitors fighting in more than one category need only weigh in prior to the first day of their competition**

SEEDING OF ATHLETES, DRAW PROCEDURES, AND SCHEDULING

Seeding: The top four ranked athletes shall be seeded in Senior categories in accordance with their listing on the National Senior Elite Roster maintained by USA Judo as follows: #1 and #4 on one side; #2 and #3 on the opposite side. If any of the top four ranked athletes are not in attendance, the other athletes will be "moved up" accordingly, i.e. if #2 is not in attendance, #3 and #4 will be seeded as #2 and #3, respectively. Athletes ranked below #4 shall not be moved up. Seeded athletes will be separated as far as possible in their sections of the draw and will receive byes if available. A higher seeded athlete will always receive a bye before a lower seeded athlete. Seeded athletes lose their State/Club/School affiliation for purposes of the draw, i.e. two athletes from the same state, club, or school may meet in the first round if one is a seeded athlete. (Board approved April 17, 2003 – minutes corrected, October 10, 2003)

Draw: The draw will be conducted using USA Judo-approved software. After the seeded athletes are placed, the draw will be random, with the restriction that players having the same School affiliation will be placed as far apart in the bracket as possible.

Match Scheduling: The Texas Match Scheduling system will be used. Contestants will receive a card specifying their contest area number and match number. All contestants are expected to report to their assigned contest area 3 matches prior to their assign match number.

Uniforms: The Blue and White judo gi rule **is in effect**. It is mandatory that the first athlete in each pair of contestants called wear a blue judo gi, the other athlete must wear a white judo gi.

Golden Score: The Golden Score (sudden victory) overtime rule will be in effect at this event.

Match Times: 5 minutes.

NOTICE OF POSSIBLE TESTING FOR BANNED SUBSTANCES

For the IJF Junior (formerly Juvenile C) Categories and Collegiate Categories only, testing, in accordance with procedures of the U.S. Olympic Committee may be conducted by the United States Anti-Doping Agency (USADA) - the independent testing agency for Olympic sports in the United States. In the event there is a question concerning whether or not a substance is on the list, you may call the Drug Reference Hotline at 1.800.223.0393. JUNIOR (NON-COLLEGIATE) CATEGORY AWARDS

- **Individual Awards:** Gold, Silver and Bronze medals will be awarded for first, second and third places for all divisions
- High School All American Certificates will be given to **ALL** 1st place winners. Academic All-American Certificates will be awarded to all entrants with a 3.0 cumulative grade point average or higher. The Academic form is required in order for High School All American Certificates and Academic All-American certificates to be awarded.
- **Special Awards (to both male and female):** Best Technique, Fighting Spirit and Outstanding Competitor. The members of the National Junior Subcommittee who are in attendance will be the selection committee for the special awards.
- **Team Awards:** The following High School Team Awards will be presented:
 - 1. Individual High School Award:** Based on Total Number of Medals. Those high schools with the same number of medals will be sorted by #gold, #silver, #bronze. Awards will be presented to the winner and runner up. The Academic form is required in order for medals to be counted
 - 2. State High School Award:** Awarded to the state with the most points based on a point system of five for gold, three for silver, and one for bronze. Certificates will be presented to all high schools in the winning and runner-up states. The Academic form is required in order for medals to be counted.

COLLEGIATE CATEGORY AWARDS

Individual Competition: **Medals for 1st, 2nd and 3rd places for Novice and Senior divisions**

Outstanding Male Player: presented to the outstanding male contestant for Senior Divisions.

Outstanding Female Player: presented to the outstanding female contestant for Senior Divisions.

The outstanding players will be chosen by a committee composed of selected members of the USA Judo National Coaching and Training Subcommittee .

Winners MUST be in regulation judo uniform or team sweats (track suit) to accept awards.

The tournament director reserves the right to make all final decisions on events related to and surrounding these championships.

EARLY REGISTRATION, ENTRY FEES, TOURNAMENT CHECK-IN

Early Registration: The official entry form and all other required forms must be fully completed, properly signed, appropriate fees enclosed, and mailed to the address stated on the entry form, **postmarked no later than February 15, 2009**. All others will be considered late entries.

Entry Fees

Early Registration: Entry fee for entries postmarked no later than **February 15, 2009** is **\$90.00**. Personal Checks, Business Checks, Money Orders, Traveler's Checks, Certified Checks, Cashier's Checks only. **Athletes competing in a second category will pay \$75.00 for early entry for the additional division and \$85.00 for late entry into the division. Checks should be made payable to: 2009 USA JUDO Youth and Scholastic National Championships.** If paying by credit card, include Credit Card Charge Request form. **DO NOT MAIL CASH.**

Late Registration: Official entry forms **postmarked after February 15, 2009** will be considered late entries. Late entries must pay an entry fee of **\$110.00**.

DO NOT MAIL ENTRIES AFTER March 10, 2009. After this date, entries should be hand carried to the tournament for Friday, March 27, 2009 check-in, and will be considered **walk-up registrations with an entry fee of \$130.00**. See below for acceptable methods of payment.

Walk-Up Registration: Contestants also may register during Tournament Check-in. All forms must be properly completed and signed at that time and the **walk-up registration fee of \$130.00** will be expected. **Cash, Money Orders, Cashier's Checks, Certified Checks are the only accepted forms of payment for walk-up registration. Credit Cards, Personal or Business Checks will not be accepted for walk-up registration.**

ENTRY FEES ARE NON-REFUNDABLE!

Incomplete Entry Materials: Entries with incomplete or missing information will be considered late entries unless the required material is received before Tournament Check-In. You will be informed by mail of incomplete or missing information and given opportunity to properly submit all materials prior to Tournament Check-In. **NEW: Incomplete Entry Forms lacking signatures, fees, or any requested information that is not received in advance will be charged a total of \$130: equivalent to a walk up registration.** PLEASE CHECK YOUR FORMS CAREFULLY FOR COMPLETENESS!

During Tournament Check-in, all late or incomplete registrations will be required to properly complete all forms and pay the appropriate fees.

All required forms must be properly completed and signed and the appropriate entry fees paid regardless of when the player registers. **Refer to the checklist of required items listed elsewhere in this flyer. The tournament director reserves the right to make all final decisions in relation to this event.**

IMPORTANT - Confirmation of Registration

Enclose a stamped, self-addressed envelope to be informed whether your registration is complete, or whether any items are missing. Missing items received before the start of Tournament Check-In, will complete registration. Otherwise, **you will be expected to provide the missing materials at check-in and pay the late registration fee of \$130.00.**

Tournament Check-in and weigh-in for **Juvenile and Intermediate 1, Senior Collegiate Divisions** will be held at the Tournament Headquarters hotel on Friday, March 27, 2009. **Bantam / Intermediate 2 / IJF-Juniors and Collegiate Novice Divisions may register ONLY at the Tournament headquarter hotel on Friday, March 27, 2009 or on Saturday, March 28, 2009 at York Expo Center's Toyota Arena Weigh-ins for Bantam / Intermediate 2 / IJF-Junior / Novice Collegiate divisions will take place at the York Expo Center's Toyota Arena on March 28'2009.**

Absolutely no entries will be accepted after 6:00 p.m., March 28, 2009.

A calibrated practice scale will be available prior to, and during, the weigh-in periods. However, in no case will contestants be allowed on the Official Scale during Official Weigh-in for the purpose of checking weight. Contestants may check weight as many times as desired prior to the designated time of the official weigh-in. A contestant is given only one chance on the official scale during official weigh-in. **At weigh in, athletes must present their tournament-issued identification card AND all athletes in the Juvenile A, Juvenile B, and IJF-Junior, Senior Collegiate and Novice Collegiate categories must present a photo ID.**

All contestants must compete at their true age (exception: IJF-Junior Category, Collegiate Categories) and weight except where the contestant is uncontested. In the case of an uncontested competitor, the competitor may either move up into a higher weight bracket of his/her age or into the IJF division if appropriate. The tournament director reserves the right to make all final decisions for this Championships.

Draw:

Divisions will be posted for coach/player inspection as soon as possible after the close of weigh-ins on each day. One hour later, any necessary corrections will be made, the draw will be performed, and brackets, with match numbers, will be posted.

Junior Categories (Non- Collegiate) of Competition and Weight Divisions

Please note that each Category is based solely on the year in which the contestant was born. The contestant's actual age on the day of competition is irrelevant. All Weights listed below are in

kilograms. For each weight division, the weight range will be over the next lower weight and up to and including the weight listed. Exception: PJU lightweight in the IJF-Junior Category (explained below).

Example: Bantam 1, 28 kg – over 23 kg and up to and including 28 kg.

The Tournament Director reserves the right to make changes in the highest and lowest weight classes in the BANTAM and INTERMEDIATE divisions when it is in the best interest of the contestants to make these changes due to differences in weights.

The following age/weight categories will be in use **for this year's event (2009):**

BANTAM 1 (Born 2003): Female AND Male: 19, 23, 28, +28 kg	INTERMEDIATE 2 (Born 1997-1998): Female AND Male: 28, 31, 34, 38, 42, 48, 53, +53 kg

The IJF-Junior Category is the same as the International Judo Federation Junior World Championships Category. This means that there is no lower age limit. Athletes may enter if they are born in 1990 or later (1990, 1991, 1992, 1993, 1994 etc.).

Clarifications to IJF Junior Category:

1. The Pan American Judo Union (PJU) lightweight divisions, 44kg for women, and 55kg for men, will still be contested for PJU team selection purposes. Athletes whose weight would normally place them in these PJU divisions may elect to compete in the next higher weight divisions for Junior World Team selection purposes.
2. For some PJU events, eligibility is restricted to athletes born in 1990, 1991 and 1992 only. Therefore, athletes who are nationally ranked in the IJF-Junior Category but do not meet the PJU year of birth requirements, will not be eligible for USA team selection in such events.
